HISTORY

This residence is a mobile home which had been moved onto the property in about 2011. At one time, an older home, from the 1800's had been on this property, torn down to make room for the mobile home. There are large number of Native American artifacts found on the land, indicating their presence, also. There is a pond about 300 yards from the home, at which visitors often feel a sense of foreboding. Activity seems have picked up in the last three months prior to investigation.

EXPERIENCES

There are a reports of a possible female spirit presence, including visual and interactive. Objects of all types are moved around on a regular basis, with no one having been in the area at the time of moving. The pond area seems to have a heavy atmosphere.

INVESTIGATION

DATE OF INVESTIGATION: August 22nd, 2015

PARTICIPANTS: BESS MAXWELL, KEITH MYERS, KIRK CORMIER, CONNIE WILLIAMSON, TRACI MYERS

EQUIPMENT: Digital Cameras, Infrared cameras and DVR system, Digital audio recorders, Ion Counters, P-SB7 Spirit Box, Infra-sound detection equipment, Digital thermometers, Various EMF meters including Tri-Fields, Motion detectors including geophone and laser grid systems, Ovilus interactive voice communications device, and PEAR REG-1 units for the detection of anomalous human consciousness with software on Hewlett-Packard computers.

INVESTIGATION: At the time and places tested, no anomalous photos were taken. No data was noted on video. Nothing unusual was detected by laser grid or geophone. No high EMF fields from AC current were found in any location likely to result in prolonged exposure, although there are some areas of high EMF fields from wiring. No anomalous hot spots or cold spots were noted. No anomalous motions were noted. Three EVP voices were recorded. No EVP words formed by the P-SB7 were noted.

PERSONAL EXPERIENCES

CONNIE WILLAIMSON indicated feeling a sense of an unseen presence, with accompanying dizziness at various locations in the home.

THE MODEL P-SB7 SPIRIT BOX

This device utilizes a milli-second adjustable forward or reverse sweep technique coupled with a white noise distribution between frequency steps. This is designed to add ambient sound energy for the production of real time EVP, allowing for instant feedback in communications attempts. See item 16 in "General Parameters of the EVP Phenomenon".

NO DATA IN AUDIO WAS OBTAINED ON THE P-SB7.

CONCLUSION

At the time and places tested, no anomalous photos were taken. No data was noted on video. Nothing unusual was detected by laser grid. No high EMF fields from AC current were found in any location likely to result in prolonged exposure, although there are some areas of high EMF fields from older wiring and electrical devices. No anomalous hot spots or cold spots were noted. No anomalous motions were noted. No EVP voices were made of words formed by the P-SB7. Three EVP voices were recorded by standard digital recording. No excessive positive ion counts were noted. No infrasound, nor standing waves of such, were detected at times of testing, in the areas of testing. The consciousness testing was strong, and consistent in many areas. We feel that these experiences, and the positive tests received are probably indicative of an anomalous presence or presences, and that these do not seem malicious or harmful in any way.
